4. The member will be notified of any change in monthly payments prior to collection.
5. A member's membership may be suspended from the date of payment default, if the member fails to:
  - maintain a direct debit mandate; or
  - make a payment to FFL within 7 days of the due date; or
  - comply with the terms of this agreement.
6. In the event of default as described in the point 5 above, the member wishes to continue for the remainder of the then current membership period, the member must pay FFL an amount equal to the to the outstanding unpaid fees due in respect of the current membership.
7. The collection of payment does not imply that membership is in force.
8. FFL shall not be liable to the member for any act, omission or default of the golf club.
9. The golf club is not an agent of FFL.
10. Any alteration in arrangements shall not affect the terms of the agreement between the member and FFL.
11. The terms of this agreement will apply to any renewal unless advised by FFL, on or before such renewal.
